Cuddeback UESD has a history of open communication and engagement with our stakeholders and community members. The efforts to gather meaningful input for the ESSER III plan started with information previously gathered from similar community engagements related to recent plans like the district LCAP, LCP, and ELOG plans. Much of the same information from these plans applied to the development of the ESSER III plan, and involved consultation with the same important groups of stakeholders such as students, parents, parents of underserved students (including low income, foster youth, students with disabilities), teachers and support staff, Parent Advisory Group, and the governing board. CUESD does not have a bargaining unit or significant association with any tribes or civil liberties organizations.

The district utilizes many forms of communicate in reaching community members. These include online surveys, public comment opportunities at governing meetings, automated general information calls, paper surveys and response flyers, and especially through parent small group or 1:1 personal conversations at school.

In addition to these previous engagements, the district sought input from stakeholders via School Board agenda items in September/October 2021. Teachers gathered input from their students to share at multiple collaborative staff meetings in September/October 2021, along with their own feedback as educational professionals.

Community members shared that addressing the social/emotional needs of our students was a priority considering the disruption to regular learning and social/emotional growth and development that students missed due to the pandemic. This plan will allow for an increase in SEL counseling services for our students in need.

Parents and teachers agree that additional time and efforts are required to recoup academic growth lost as well. The district plans to implement a summer school program designed to deliver academic support, remediation, and preparation for the next grade level to students identified. The district will also provide certificated tutoring and intervention after school to students.

Parents and educational leaders acknowledge that a modernization upgrade to the school cabling infrastructure is vital for access to 21st century curriculum and materials in the classroom and in the event of any further required online learning. The ESSER III plan incorporates such an upgrade to provide students access to learning.

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.
